

The President's Report Lunch with the Presidents

On August 6th, it was my great pleasure to have lunch with two of the Branch 111 former presidents. Tom McPartland and Steve McNees (pictured) were the Branch Presidents that I knew in the 1990s, followed by Mike Miller in the early to middle 2000s. McNees did two terms, followed by McPartland for one term, followed by Miller for two terms. These and many others (Mike Madsen, Rich Doucette, Bob Gunn, Kirk McLaughlin, Bob Jewell, Sharla Groves, and more that are lost to time), taught me how to be a Shop Steward, and a Branch growth. Officer. It was a different time back then, cell phones were pay-by-the-minute, so after Letter Carriers were out of the office, phone calls were rare and short. The branch used to file about 200 grievances per year, whereas now we average around 3000. Back in those days contract



knowledge was a well-kept secret, and those in the know were often seen as having "power". I am grateful that our branch did not keep those contract secrets. All of the above-mentioned leaders shared their knowledge and experience freely, mentoring the next generation (Jeff Asay, Karen Ewell, Phil Rodriquez, Terry Ehlers, and many others), and we in turn did the same for the next generation, and so on and so on.

Lunch with our former leaders reminded me that our time passes, and the next generation will always take over. Passing on our knowledge and experience empowers the next generation to succeed, because they can learn our "best practices", while also learning to avoid our mistakes. And most importantly, the next generation will always have a foundation and a framework that they can build upon; they never have to start from scratch. I have so much gratitude for the giants that preceded me, both for their service to the branch, and for their generosity of experience, and for all the negotiations and settlements that became the basis for our growth.

The funny thing is that I didn't always get along with the above-mentioned people. There were occasional disputes, and tempers flared. But in the end, we found ways to respectfully disagree, and that is the key to working well as a group. In business, when 20 people agree with each other, then 19 of them are unnecessary. Different views create better solutions, because more options are considered.

The last thing I want to say is that Branch 111 is always looking for future leaders, officers, or simply people who want to participate.

If you have been thinking that it is time for you to step up and represent, or perhaps you feel that management has been running roughshod over the contract, and you would like to fight for our collective rights, then please give me a call at the Union Hall.

I promise that the current officers of Branch 111 will share our experience and knowledge with you, at least as much as we are able to, because that is exactly what happened to us when we started.

Vice President's Message:

Family Medical Leave Act of 1993

FMLA should be utilized by any employee with a qualifying condition, to protect themselves against discipline. Management attempts to discipline us all the time for not being regular in attendance. One way to protect ourselves is by making sure that we are covered by FMLA when we qualify for it.

FMLA provides certain employees up to 12 weeks of unpaid, job-protected leave per year. It also requires that their group health benefits be maintained during the leave.

Employees are eligible for leave if they have worked for the USPS for at least 12 months and have at least 1,250 hours over the past 12 months. eligible letter carriers up to 12 weeks of leave each postal leave year, for:

- A new child in the family—by birth, by adoption or by placement in foster care;
- Caring for a family member with a serious health condition;
- The employee's own serious health condition that prevents him or her from performing the job, or
- Qualifying exigencies arising out of the fact that employee's family member is on or has been notified of "covered active duty" in the Armed Forces.

The necessary paperwork can be obtained online by googling the DOL Form or the FMLA NALC forms. If, for some reason the FMLA is denied solely because the NALC form was filled out, please ask your steward to file a grievance as it is an acceptable form to submit to HRSSC FMLA. If your doctor is faxing the form please ask them for a copy of the fax receipt. Then you can ensure it was sent to the correct fax number and within the time frame. You can always fax it yourself as well to ensure that it is properly and timely submitted. The following is the proper mailing address and fax number:

Vice President's Report

Convention 2024 "Boston"

If you have been lucky enough to attend a National Convention -regardless of the city- you know what a tremendous experience it is. The convention is very well done and the experience of joining thousands of other letter carriers from all over the country is truly amazing. I have been blessed to have attended a convention in Chicago in 2022 and recently in Boston. Two wonderful cities with so many things to see. There are letter carriers everywhere you go, on the street, at the sites, and of course at the convention itself.

Day 1:

The 73rd Biennial Convention of the National Association of Letter Carriers began on Monday, August 5th. At 10:00 AM the convention was called to order by National Secretary-Treasurer Nicole Rhine. After

the singing of the National Anthem and Pledge of Allegiance, President Renfroe addressed the membership. President Renfroe spoke about progress and solidarity and then updated the membership on collective bargaining. President Renfroe touched on NALC's primary goals:

- Obtain wage increases and maintain cost-of-living protections
- Eliminate the two-table wage structure and replace it with a single pay table
- Maintain healthcare and retirement benefits
- Maintain protections against job threats such as subcontracting
- Negotiate changes to work rules that would benefit NALC members.

Renfroe said "Today we are near agreement on the major economic pieces of a tentative agreement."

Following Renfroe's remarks AFL-CIO president Liz Shuler spoke to the delegates. After President Shuler's remarks there was business to conduct.

The convention discussed a motion to overturn

President Renfroe's ruling that three members do not have standing to appeal the decisions by the Executive Council that found the NALC president not guilty of three charges. In a teller vote, the motion carried 2,221 to 1,596. Meaning the delegates would hear the appeals by the Wednesday of convention week.

Day 2:

At the top of the second days agenda the convention voted to endorse Vice President Kamala Harris for president by a overwhelming vote and when Renfroe announced "The NALC proudly endorses the Harris Walz ticket, and we will do all in our power to ensure that Kamala Harris is the next president of the United States", which received a standing ovation from the delegation.

The convention then heard from Roxanne Brown of the United Steelworkers Union, APWU President Mark Dimondstein and an inspiring speech by International Association of Fire Fighters President Ed

Kelly. Last we heard from National Postal Mail Handlers Union President Paul Hogrogian addressed the delegates. Following some housekeeping and starting the voting on a few resolutions, the convention adjourned for the day.




Early on day three a motion to have President Emeritus Rolando chair a hearing of articles to appeals, to be held during the afternoon session, was passed by the delegates. President Renfroe introduced speakers on day three

including, UNI Americas regional secretary Marcio Monzane and Rep. Katherine Clark -the minority whip in the U.S. House of Representatives.

Then it was down to business and President Renfroe handed the gavel to President Emeritus Rolando who presided over the discussion. Rolando read Article 10 of the NALC Constitution and laid out the process by which the charges had been made, investigated and decided upon by the Executive Council. President Emeritus explained the 3 appeals and explained each charge would be handled in turn. Director of City Delivery Chris Jackson was allowed 20 minutes to present his case to overturn the ruling of the Executive Council on charge 1, the Neglect of Duty.

President Renfroe was given 20 minutes to present his case. Both parties were given 5 minutes for rebuttal. After hearing the appeal, the delegates voted to uphold the Executive Council's decision of not guilty on charge 1 with a teller vote of 2,997 to 1,576. President Emeritus Rolando asked the convention to continue the process as soon as the convention on Thursday.

Day 4:

The appeal for charge 2, Circulating False or Misleading Statements about an NALC Officer, was then heard by the same process as the previous charge 1. Ultimately, a teller vote of 2,949 to 1,478 upheld the Executive Council's ruling of not guilty. Jackson then had his appeal heard for Charge 4, Abandonment of Position. The teller vote for charge 4 was 2,674 to 1,712 to uphold the Executive Council's ruling of not guilty. Garden Grove, CA Branch 1100 member Charlie Miller had his appeal heard for the penalty the Executive Council imposed for Charge 3, Impaired Driving in an NALC owned vehicle. The teller vote for Charge 3 was 2,783 to 1,438 to uphold the Executive Councils penalty. The process of hearing the appeals took a very long time but it was important to hear because that is what the delegation voted to do back on day 1. A tremendous amount of work was left to do on voting on the dozens of resolutions proposed by many delegates.

Final Day:

Day 5 was all business and the delegation powered through the resolutions despite staying late and many delegates leaving to catch flights home but the task was completed.

The convention this year was unlike any other convention that came before it. Long days and unprecedented business conducted and at the end of the day I would say it was a positive convention and the voice of the delegates was heard.

- In the new contract, they are trying to create an easier way to signup for LCPF. We had a couple of new PTFs from downtown signed up for LCPF this last month. Nationally, they are pushing to pass the Letter Carrier Protection Act.
- LCPF donated \$5,000 to John Curtis' campaign this last year.

MDA COORDINATOR by Nathan Chester

• \$4,633 has been raised so far this year for MDA. • He is concerned that we have spent too much money on prizes for drawings. With nearly 1,200 members, even an occasional \$1 donation should bring in more money. DIRECTOR OF VETERAN AFFAIRS by Jimmy Fleming • no report

LEGISLATIVE by Chad Mortensen

- At a debate one candidate told everyone that unions were horrible and the vote by mail was a fraud. Most elected officials have some abilities to make a difference in our jobs. We need to support people who will protect our jobs.
- •Monnica Manuel (West Jordan) is running for State Senate and would like to speak to us, maybe next month. Who do Letter Carriers support? Those who support us. It is very import that we all support LCPF to support our supporters. It does matter to protect our jobs.

TRUSTEES by Chad Mortensen

• The Trustees didn't meet this month because Chad was not available. Mike Madsen will open up the books and show anyone that wants to know what is going on.

MBA / COMPENSATION by Bob Jewell

• The Orem office filed and won a grievance that will have Bob go there and train the postmaster and all 6 supervisors on OWCP regulations. • Management claims that they can't pay COP until they have all of the documentation. That is not true. COP is to cover the time during which the documentation is collected (including medical documentation).

HEALTH BENEFITS by Jim Kerekes

- A recent Retiree Newsletter came out explaining the new health program, PSHBP. New programs affect retirees more than active. A new platform for selecting health programs is coming out before the open season (Nov 11- Dec 9). A bulletin came out explaining how to enroll in Medicare Part B. Sept 30 is the last day to send in your form.
- Before open season, retirees will receive information on which plan under the new program is most comparable to their current plan. You should review the new plan to make sure it covers your needs. You will be transitioned into the new plan unless you choose another during open season. •Medicare has a booklet that will help. If you are an annuitant you need to remain in Medicare Part B. Part B will cover the co-payments. If you don't have Part B you will have to pay much more on bills. Part D was required to be in the health programs. New retirees will be automatically enrolled.
- Those on Silver Script need to fill out the paperwork to get their \$600 rebate this year. Medicare Advantage Plans You have to suspend your insurance plans to get an Advantage Plan or outside plans. When you turn 65 you have to sign up for Part B or you will lose your health benefits. Call Jim if you have any questions.

SAFETY AND HEALTH by Justin Lindquist / Nathan Chester

- Nathan: Tony Cline showed up to the last meeting. SL City accidents are way up lately. Hitting fixed objects has been one of the main reasons. Management wanted to know why they were having so many accidents. He indicated that carriers are getting better about reporting accidents. Reporting heat problems in the office has been effective lately. If the air conditioning in your office isn't working properly, turn in a form 1767. 91 of 105 PTF positions are filled. If your restrooms are breaking down or dirty, fill out a 1767 (or call OSHA) to get the necessary supplies. Tony Cline said he would make sure you get it. The snow plows won't be called to plow the parking lots if the snow isn't a certain depth. Still, they are required to provide a safe work place. Complete form 1767 if it isn't safe.

DIRECTOR OF RETIREES by Jeff Asay

• The Retiree Dinner is October 24th 3:30-5:30 at the Draper Chuck-a-rama. • Most changes coming up (health benefits, OWCP, etc) will probably be done using a computer. Sign up for your government account NOW, so that you don't run into a last minute problem.

TREASURER by Mike Madsen

• 3 years ago we had \$225,000 in savings. We now have \$133,000 of which \$61,000 is progressive permissive remedies money. \$75,000 is all we have left from three years ago. • We need to start thinking about what we want to spend and what dues will have to be to pay for what we want/need. • This month: \$5,800 progressive/permissive awards, \$35,000 income, \$43,800 expenses for an \$8,800 negative flow. • We need to prepare to create a balanced budget for next year. We reduced our dues three times in past years.

VICE PRESIDENT by Destiney Carrillo

• The Shop Steward dinner is next week. Have a good week.

EXECUTIVE VICE PRESIDENT by Mike Hansen

• 2,373 grievances filed so far this year. • The steward dinner is next week. 60 people are going so far. Dinner tickets are available online (contact Mike for help). It will be held at the Bee's baseball game.

PRESIDENT by Mike Wahlquist

• We did reduce our dues three time since about 2015. We did this to keep our dues below \$30, mostly for organizing purposes. Now our dues are at about the national minimum and we need to rethink this. • There were 2 assaults on carriers in the last 2 weeks. There were no injuries or property damage. There are supposed to be personal safety standups in every SLC office in the morning. • If you are accosted on your route or anywhere else while at work, you do not fight. You give up your mail, arrow key, scanner or whatever else they ask you to do, then call management. First and foremost, you take care of yourself. •The rap session attendees are selected and their funding will come out of the progressive/permissive remedies fund. • The 84103 zone intervention has been going on for months. About 6-8 weeks ago management pulled out of the agreement (at the area level). Locally, they are still working to clear up the remaining grievances and problems. • We still don't have a national contract.

• National has changed the rules so that new retirees who didn't decide to remain in the union can now sign up after years, and not have to pay back dues. The only requirement is they must be in good standing at the time they retired (no retiree back dues will need to be paid).

The HATCH ACT and You!

As we enter into the 2024 political season, please be aware that Letter Carriers are regulated by federal law from certain political activities via the Hatch Act. Please be aware of the Do's and Don'ts to prevent any issues.

Do's (while off the clock, out of uniform)

Active letter carriers may—on their own time, away from work, out of uniform and without using a postal vehicle:

- Be candidates for public office in non-partisan elections (that is, elections in which none of the candidates are to be nominated or elected are representing a political party).
- Register and vote.
- Sign and circulate candidate nominating petitions and ballot initiative positions.
- Assist in voter-registration drives.
- Speak and write publicly and otherwise express opinions about candidates, ballot measures and issues.
- Attend political rallies, meetings and other events.
- Attend fundraisers and contribute money to political organizations and campaigns.
- Volunteer for political campaigns and encourage others to volunteer.
- Participate in phone-banking and precinct-walking for candidates and ballot measures.
- Display bumper stickers, lawn signs and other campaign paraphernalia.
- Raise money for the Letter Carrier Political Fund from other NALC members. (Note: Letter carriers while detailed to 204b or other higher level assignments should not solicit contributions to the Letter Carrier Political Fund from postal employees who may be viewed as their subordinates.)
- Volunteer, run for and hold an office in a local or state political party or club.

Don'ts (while on the clock, at the workplace, in uniform or in a postal vehicle)

Active letter carriers may not—while on the clock, at the workplace, in a postal uniform or in a postal vehicle—engage in any of the otherwise permissible political activities listed in the "Do's" above. For example, while on the clock, at the workplace, in a postal uniform or in a postal vehicle, you may not:

- Send or forward a partisan political e-mail.
- Wear or display any political or campaign material, even as a computer screen-saver or desktop wallpaper.
- Circulate partisan political materials to co-workers.
- Sign up electronically to contribute to the Letter Carrier Political Fund or solicit other letter carriers to contribute.

Don'ts (ever)

Active letter carriers may not—even on their own time, away from work, out of uniform and without using a postal vehicle:

- Use their official titles or positions when engaging in otherwise permissible activities.
- Raise money for partisan political groups or campaigns (except for the Letter Carrier Political Fund), including phone-banking, letter-writing, selling tickets, hosting a fundraiser, inviting people to attend a fundraiser, or allowing your name to be used in a fundraising appeal.
- Otherwise solicit, receive or handle contributions for a partisan political group or campaign.
- Run for elective office in partisan (party-label) elections (even if you report "No Party Affiliation").
- Raise money for the Letter Carrier Political Fund from non-NALC members (except from their immediate family members in the same household).

Health Benefits

The Special Enrollment Period ends September 30, 2024.

Under the special enrollment you should have received a letter to sign up for Medicare Part B without having to pay the penalty. You need to fill out and return the letter, postmarked no later than September 30th, or you won't be signed up. If you didn't get a letter, you're probably too late. Hopefully you get this information in time.

If you belong to the Silver Script Drug Program, you have until the end of this year to get your \$600.00 reimbursement. Don't wait to get that (you've already spent \$600.00 worth of expenses to get it).

I believe next month some time you'll be receiving more information as to the new health program. Check with OPM.gov/insure and keepingposted.org to see if there is new information. Be sure and get signed up with OPM, with your own log-in. Get help if you need it!

Safety and Health Message:

Take Care Of Yourselves and Each Other!

As we progress through our careers as Letter Carriers, it's more important than ever to protect ourselves from the many risks we face to our safety and health. Being a letter carrier is a hazardous job. However, there are some things that we ought to do to make sure we remain safe and healthy.

- Remind yourself to set a goal each day to finish each day as healthy as you started it.
- Learn the M-41 and follow it for carrier duties and safety practices
- Be selfish with your safety! Never compromise your physical health to "make numbers".
- Take note of "close calls" and plan to avoid those situations in the future
- Pay attention to your own body and adjust work practices as necessary. Minor aches and pains could signal a repetitive motion injury in the future.
- Only drive while driving! Resist the temptation to look at mail, packages, scanners, etc. while driving. Practice keeping both hands on the wheel, and both eyes on the road until completely stopped at the park point.
- Demand a safe work environment! Management must provide a safe and healthy work environment. Carrier's work environment includes the postal facilities, mail trucks, equipment, and conditions on your routes. Document all safety hazards with management and stewards. If needed, fill out a 1767.
- Work at a pace you can maintain for your career without putting too much stress on your body. Bodies and joints wear out, make sure you protect yourself now for a happy retirement later.
- Get involved! Volunteer to be on your station's safety and health committee.
- Watch out for each other. If you see a fellow carrier doing something unsafe, kindly remind them that they should not sacrifice their personal safety for a job.

Branch 111 strongly encourages its carriers to work as safely as possible! You matter far too much to sustain any injury. Take care out there!
