Treasurer by Mike Madsen

- The 2016 budget was handed out for discussion next month, last year we organized well, especially CCAs, and we have more money than expected. The second page has a line item for a new copier; there are so few copies of the budget because the copier isn't working. We have 30 days to review the budget, will discuss next month.
- The charges for RAP session changed, because we now pay the registration with the room charges. Another set of charges were billed 30 days later to all ten rooms as an amenities charge. Will figure it out.

Vice President by Jeff Nelson

- We had 745 grievances in 2015 and are now at 135 for 2016, not a good start.
- Check with the CCAs in your office to ensure they are getting their training, OJI training and Carrier Academy, especially in the AOs.
- Will be working as a CDL in the second district.
- Life insurance, FEGLI rates for retirees will increase. Has rates available tonight, also on the website.
- The APWU contract will be going to arbitration, Steven Goldberg arbitrator.
- Has information on protecting yourself from cold stress.

President by Michael Wahlquist

- The Heber grievance agreement regarding rural carriers carrying city mail, management has defaulted on grievance agreement.
- Bountiful, interviewing every carrier on the working conditions there. The shop steward there is doing an excellent job.
- National CCA conference, Justin Lindquist from our branch was selected. Will be leaving for St Louis this Saturday.
- We had an audit last month, we did fine.
- A carrier in Bountiful has been charged with delay of mail, the OIG has criminally charged the
 carrier with delaying the mail. We can expect more of this here; will be the topic of the next
 article in the pavement pounder. Use a 1571 when mail is brought back. Management can fire
 you for a nexus if convicted.
- The copier has died, the repairman worked for a couple of days, could not get it to work, has asked for a bid for a machine that would fit our needs. It was discussed by the executive board, the bid is \$13,274 with a service agreement that includes a \$295 per month which includes toner, another bid for the same machine \$13,752 with a \$215 monthly, another bid for \$12,074 with a \$125 service agreement, a lesser model is available for \$10,100 with a \$215 service agreement. We don't currently have a working copier. It was moved by Mike Madsen to forgo the 30 day waiting period and discuss this one line item now. Seconded. It was moved by Sharla Groves to approve the line item, allowing the branch to purchase a copier. Seconded. Motion carries with a voice vote.
