### Good of the Association

State President, Phillip Rodriquez was asked to report on the status of contract negotiations;
 PMG Brennan is negotiating fairly with the NALC. Some of the points being negotiated include:

higher pay grades, CCA and TE credit for time in service. President Rolando and the PMG have been discussing the climate of the Post Office, and have a new ambassador program, similar to the old El program. Article 8 and dignity and respect are being discussed. CCAs have a 54% turnover rate. The transfer memo is being discussed as well as the probationary period. Too many CCAs as well NALC leadership going into management. The union and management are attempting to determine how much time value for parcels to create biddable routes. 25,000 routes have been added with CDRAAP. Amazon Fresh is coming to Salt Lake City, grocery delivery.
