LEGISLATIVE by Chad Mortensen

VICE PRESIDENT'S REPORT by Mike Hansen

1,339 grievances filed so far this year. Most are contractual such as 12-hour violations. Attendance is still a problem.

•Steward's training is next Wednesday at 6:30pm.

PRESIDENT by Mike Wahlquist.

•Lance Henrie was honored for his service as the Branch Vice President. He did a great job while working long hours. He was given a 1/25 scale 1932 Ford. He said he loved working as the VP. •Steward Elections will be March 30-31. If nobody runs for the position, the steward may be appointed from someone in the unit or outside the unit. •Food Drive – we need a food drive coordinator. The position has 40 hours budgeted with travel reimbursed. You may have to take time off work to attend meetings. You have a management counterpart. You then coordinate the distribution of bags and cards and help coordinate with the Food Bank. Contact the President if you are interested. •The audit report from the Department of Labor came back. They gave a few recommendations but reported no problems. They still haven't returned 5 years of files they took to review.

SPECIAL ORDERS:

Initial readings of 2 proposed bylaws changes (voting next month)

• *It is proposed that we eliminate the position of the Executive Vice President in Branch 111, and all attendant references in the Bylaws.*

• *Any approved budget cannot exceed the estimated revenue for the year.*

TREASURER by Mike Madsen –

•The DOL would not tell the branch who the accusers were that initiated the audit of 5 years of records. The auditor said he found no indication of embezzlement by anybody. • Last Month's Finance Report: Income \$25,044, Expenses \$30,583, Net Loss \$5,539

•The proposed budget for this year was presented (copies available). Line items to be discussed were to be held out. Held out: Muscular Dystrophy *\$8,500. It was moved to vote on the budget excluding Muscular Dystrophy. The motion (budget) passed. • It was proposed to change Muscular Dystrophy to \$5,000. The motion failed. It was then voted to approve the \$8,500. The motion passed. The budget was approved as originally presented.
