**Minutes of the Regular Union Meeting**

**Roll Call** by Steve McNees

**Reading of the Communications** by Steve McNees.

By letter dated 10/27/20, supervisor Karl Lopez, of the Holladay branch, has notified the branch that he has filed a Whistleblower Complaint with the US Office of Special Council against the union. He charges that Branch 111 is unethical with its application and interpretation of the national agreement. He also claims that the union is blind to the corrective action and management rights Articles. Specifically, he claims the union is clogging the system with repetitive grievances for the same things. He is upset that the union is asking for and receiving monetary remedies for repetitive violations of steward rights. He then cites 3 grievances where the Step B team has given \$700 monetary remedies to the union for repeated violation of his steward's rights. He is concerned that some management people are "just able to keep their heads above water. What level of perfection is attainable?" "I alone cannot decipher all the nuances of the National Agreement."

11/6/20 Letter to Karl Lopez from Mike Wahlquist re: Whistleblower Complaint.

Mike explains that the increasing monetary remedies are for refusing to provide stewards with appropriate steward time and requested documents. This is the result of his long track record of ignoring cease and desist orders that have not stopped repeated Steward rights violations. Surely, management would not be agreeing to these remedies at every step of the grievance procedure, including Arbitration, if the remedies were not proper or necessary. Mike suggested that providing requested union time and documents, according to our agreement, would avoid any future grievances and progressive remedies.

By letter dated 10/9/20, President Rolando informed the branch that Letter Carrier Nathan Chester's daughter, Hannah, had won the William C Doherty Scholarship Award competition. She will receive \$4,000 per year for four years for college. [Hannah thanked the members of Branch 111 for their support.]
